## **THE OPIOID CRISIS MEETS COVID-19**

or over 53 years, Cenikor Foundation has been serving a community in the crisis of addiction. An epidemic that has been taking over 200 lives per day quickly became overshadowed as we learned more about the novel coronavirus earlier this year.

Before we knew it, we found ourselves in a time of unprecedented stress and unknowns. Unemployment began rapidly rising. Social distancing guidelines and city lockdowns introduced a new level of isolation. Crowds rushed the stores leaving behind a scarcity of food and household goods. Communities were forced to scramble to obtain what they needed unlike ever before.

According to a Mental Health America (MHA) report, almost 90,000 Americans have experienced anxiety or depression as a result of the COVID-19 pandemic. Demand for our services began rapidly rising. Why? Because isolation breeds unhealthy coping skills such as those that define substance use disorder. Firsthand, we noticed a 10-20% increase of people calling in for assistance for the first two weeks.

Even in a time of uncertainty, there was one thing we all understood in the Cenikor family. The addiction epidemic preceded the pandemic and wasn't going to subside. It was our duty to continue our mission of service at this



critical time. Thankfully, as a healthcare provider, governors recognized our organization as an essential service, allowing us to continue operations.

It was not without challenges. Though we had no choice to keep our facilities open for treatment, we had an increased responsibility to protect the health and well-being of our residents, staff, and guests. Recommendations from the CDC and WHO were changing on a nearly daily basis. It took careful time and attention from our leadership team to adapt accordingly and train our staff on new operation procedures.

We focused on screening procedures, sanitization of the facilities and continuous monitoring information from the CDC, state health departments in both Texas and Louisiana, as well as the local jurisdictions of each facility. It involved some difficult decisions to temporarily suspend family visitation and the recovery support meetings open to the public.

"We worked closely with officials of the health department to do everything in our power to contain risk for infectious disease," reports Donald Goad, Senior Director. "It wasn't easy, but our mission of service leaves us with no choice but to keep fighting the disease of addiction."

For weeks, many of our clients voiced their gratitude to be in a safe environment, focused on their recovery, rather than out in the world during this time. Cenikor Fort Worth resident Galicia E\* describes her demeanor before entering the long term residential program. "I had no structure in my life. I was hopeless and completely lost," she states. "I'm thankful for the opportunity that Cenikor has given me.

The unprecedented crisis brought on by this pandemic took the world by storm. Over 100,000 deaths and rising in the U.S. may have captured all media attention, but a study by Well Being Trust and the Academy of Family Physicians estimate an additional loss of 75,000 lives to substance use and suicide.



# **LETTER FROM THE PRESIDENT**

This year has introduced a unique combination of challenges.

National attention has turned to the COVID-19 pandemic while the hidden costs have been overlooked by many. We witnessed



A recent study from Well Being Trust and the Robert Graham Center for Policy Studies in Family Medicine and Primary Care predicts that up to 154,037 American lives may be lost due to the socioeconomic impact of the COVID-19 pandemic. These projected "deaths of despair" include drug, alcohol and suicide. The unemployment rate is unlike anything we've seen since the Great Depression. Social distancing may flatten the curve of the infection rate and hospitalization, but threatens the safety of child abuse and domestic violence victims.

The nature of what we do--saving lives--provides us with the unique opportunity to be a force of hope against dire situations. A local health official has even commended our practices to contain infection, so we can continue serving our clients through the pandemic. For 16 years, I have kept the verse on my desk, Proverbs 3:5-6. "Trust in the Lord with all your heart and lean not on your own understanding. In all your ways acknowledge him, and he will make your paths straight."

As I reflect on all the challenges we have faced this year as a nation, I believe there is always room for good to overcome evil. The pervasiveness of substance use disorder continues to destroy lives, break apart families and conflict communities. We continue to stand in the gap. # **CHANGING THE GAME**

#### Telehealth Expands Outpatient Services to Virtually Anywhere

Social distancing guidelines put a strain on a person's ability to pursue their recovery. Counseling sessions, 12-step meetings, and quality time with loved ones served as a support system to keep a person focused on sobriety. The challenges of addiction recovery will not subside in times of crisis, so individuals needed an alternate way to engage these resources.

Enter Telehealth Services. To protect the safety of our staff and clients, it was necessary to provide access to outpatient services without in person meetings. The technological age we are in offered multiple tools, but we decided on the best option for our organization to conduct HIPAA compliant, confidential virtual meetings over the web and telephone. Through our secure platform, we are able to assist clients with long-term recovery. Our outpatient services include a variety of counseling opportunities facing substance use disorder and behavioral health conditions. Clients and clinicians work together to create individualized treatment plans. Through counseling, clients are empowered to make positive choices and meet personal goals toward recovery.

This is an exciting advancement for Cenikor Foundation. Our outpatient services which were initially only available at select facilities, can impact a greater community without geographic barriers. We found that by switching to Telehealth, participation increased. This solution not only protects the health and safety of clients amidst a pandemic. It increases flexibility and ease of treatment. Clients can be less concerned about timing, location, childcare, and transportation needs. He or she can choose a comfortable environment of choice.



According to the 2018 National Survey of Drug Use and Health, 89.8% of the 20.3 million people who needed treatment for substance use disorder did not receive any. Removing these barriers increases the opportunity to reach those underserved communities.

We do not discard the value of in-person treatment and will resume with the necessary health precautions when the time comes. This virtual option provides the opportunity to serve clients who are not conveniently located to our facilities with outpatient staff.

# **TESTIMONIAL: WALTER M.**

As a 14-year veteran of the United States Army, Walter M. was of the mindset that he is supposed to be a survivor who can make it in any environment. He originally didn't believe he had a drug or alcohol problem. Walter chose to shrug off his substance use as a "life problem."

"The military sent me to Cenikor because of a problem that I had," recalls Walter. "It seemed odd that [they] would send me to an outside facility."

Walter now admits that he has been diagnosed with PTSD,

Bipolar II, major depression and major anxiety. He needed help not only with addiction but the psychological trauma he faced.

"Cenikor showed me a way to combat both," expresses Walter. "The counselors here really care. They go in depth. They do their best to help in all things."

Now, Walter serves as a drug and alcohol counselor and a manager at Iron House, a sober living facility in Eustace, Texas. He proudly refers to himself as an "exaddict" and attributes his success from the help he received
